**Notice to donors:** Donors should be advised not to file your federal income tax return before you receive your contributions receipt from the church. Some donors may not be able to deduct certain contributions if you file a tax return before receiving your church contributions receipt.

**Year end contributions:** The general rule is that a contribution is effective when delivered. This means that a check deposited in the church offering in January of 2008 cannot be deducted in 2007, even if it is backdated to 2007. One exception—checks that are mailed and postmarked in 2007 are deductible in 2007 even though not received until 2008.
