Directions: For all four churches: From Staunton, take Rt 42 South through Goshen. In the Millboro area, Rt 42 turns left (south) towards Clifton Forge, but you need to continue (without turning) on State Rt 39 toward Warm Springs. Take Rt 39 over Warm Springs Mountain.

Burnsville: Follow general directions above. At the bottom of the mountain turn right (north) on US Hwy 220. Take Hwy 220 north about five miles and turn right on Muddy Run Road (Rt 614). Follow Muddy Run Road about nine miles to Burnsville that you can best identify by the crossroads (Dry Run Road). Muddy Run Road has many curves and turns, and sometimes animals are on the road. Stay on Muddy Run Road (straight through the intersection) a very short distance to the church building on the right.

Eden: Follow general directions above, at the bottom of the mountain, turn left (south) on US Hwy 220. Take Hwy 220 south about five miles into Hot Springs. In Hot Springs turn right on Rt 615. Follow Rt 615 about 2.5 miles to an intersection where Rt 687 joins from the right. Continue straight on for about .4 miles and turn right on Switzerland Trail (Rt 607). Church building is third building on the left.
